Summary of Offenses and Probable Cause Affidavit

DURING PATROL, I RESPONDED TO 4202 PAN AM BLVD (FLIGHT SCHOOL) IN REFERENCE TO A BATTERY. UPON ARRIVAL, I SPOKE TO THE VICTIM (IDENTIFIED AS SCOTT S. MCALLISTER) WHO STATED THE SUSPECT (LATER IDENTIFIED AS JOAO OSORIO) PUNCHED HIM IN THE FACE. AS I WAS TALKING TO MCALLISTER, I OBSERVED THAT HIS FACE WAS BRUISED AND HIS NOSE HAD BLOOD ON IT. I ASKED MCALLISTER HOW HE HAD RECEIVED THE INJURY AND HE STATED THAT HE AND OSORIO HAD AN ALTERCATION EARLIER IN THE NIGHT. ABOUT 10- 15 MINUTES AFTER, MCALLISTER WENT OUTSIDE TO SMOKE A CIGARETTE AND OSORIO WALKED UP TO HIM AND STARTED TO APOLOGIZE. MCALLISTER TOLD HIM THAT HE DID NOT WANT TO TALK TO HIM AND OSORIO PUNCHED HIM IN THE FACE. MCALLISTER THEN DEFENDED HIMSELF AND HIT OSORIO, KNOCKING OSORIO TO THE GROUND. MCALLISTER THEN TOLD OSORIO TO LEAVE AND STARTED WALKING BACK TO HIS APARTMENT. OSORIO AGAIN APPROACHED MCALLISTER AND STATED "I'LL WILL SEE YOU TOMORROW AT 10 AM OUTSIDE YOUR HOUSE." MCALLISTER THEN WALKED INTO HIS APARTMENT AND A ROOMMATE CALLED 911.

I ASKED MCALLISTER WHERE OSORIO LIVED AND HE POINTED TO AN APARTMENT ACROSS THE STREET.

I THEN WENT TO 4219 PAN AM BLVD TO SPEAK TO THE SUSPECT. I KNOCKED ON THE BACK DOOR OF THE APARTMENT SEVERAL TIMES AND IDENTIFIED MYSELF AS A DEPUTY SHERIFF. AFTER A FEW MINUTES OSORIO OPENED HIS BEDROOM DOOR, LOOKED OUT AND CLOSED HIS BEDROOM DOOR TWICE. D/S SERAFINI #226 THEN ADVISED ME THAT THE FRONT DOOR OF THE APARTMENT WAS OPEN. MYSELF AND D/S SERAFINI ANNOUNCED OURSELVES AND ENTERED THE APARTMENT. I THEN KNOCKED ON OSORIO'S BEDROOM DOOR AND NO ONE ANSWERED. I THEN OPENED THE BEDROOM

ASKED OSORIO WHAT HAPPENED AND HE STATED HE GOT INTO A FIGHT WITH MCALLISTER AND THAT MCALLISTER HAD BITTEN HIM ON THE ARM. I LOOKED AT OSORIO'S ARM AND HE HAD NO MARKS OR BRUISES ANYWHERE ON HIS ARM OR BODY.

I THEN PLACED OSORIO UNDER ARREST FOR BATTERY.

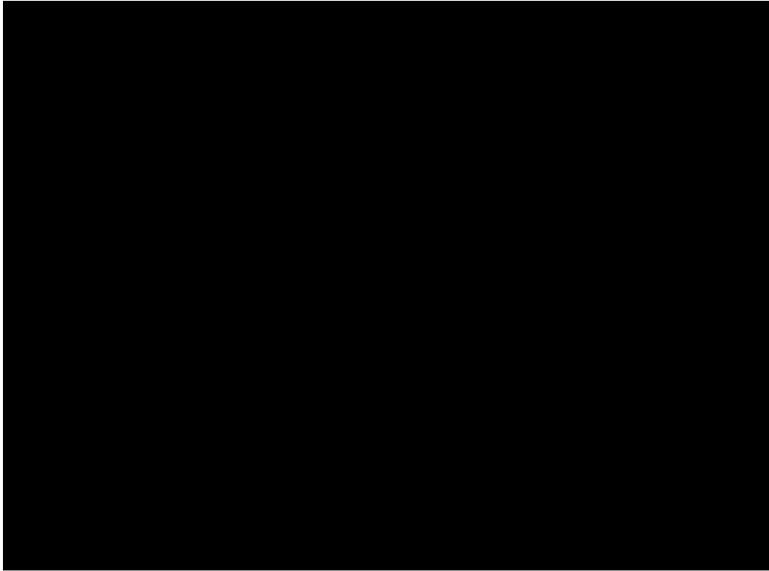
MCALLISTER COMPLETED A SWORN STATEMENT.
